FIPS enclosure	Warning: To prevent bodily injury when mounting or servicing this unit in a rack, take special precautions to ensure that the system remains stable. Important: To avoid pinching the cables when the cover is installed, make sure that they are positioned to the side before routing them up or down.

CFast card

Important: Failure to properly remove the TippingPoint CFast card can result in disk corruption and a system error.

SSD module

Important: Failure to properly remove the TippingPoint SSD module can result in disk corruption and a system error.

I/O module

Warning: Do not leave slots empty for an extended period of time. Insertion of a blank module or I/O module ensures that the device is correctly cooled.

ESD Requirements: Damage from Electromagnetic Static Discharge (ESD) can occur when electronic components are improperly handled. Improper handling can result in complete or intermittent system failures. Proper ESD protection is required whenever you handle equipment. The following general grounding guidelines apply:

- Always use an ESD wrist strap when adding or removing components from the chassis.
- Avoid touching the circuit boards or connectors on all cards and modules.
- Avoid contact between the printed circuit boards and clothing. The wrist strap only protects components from ESD voltages on the body. ESD voltages on clothing can still cause damage.

If you plan to return the component to the factory, immediately place it in a static-shielding container.

Important: Only transceiver modules (including SFP, SFP+, QSFP+, SFP28, and QSFP28) available from Trend have been validated to achieve optimal performance with TippingPoint products. Other vendor devices are not supported. Using other vendor devices could be detrimental to proper operation of the TippingPoint system.

Safety precautions

Warning: When installing the product, always make the ground connection before applying power to the unit. This equipment needs to be grounded to an external ground connection. Use a green and yellow 8 AWG ground wire to connect the host to earth ground during normal use. Disconnect the ground connection only when the unit is completely powered down.

Caution: Do not attach a ground wire to the ground screw on the DC power supply module. Attach the ground wire to the DC grounding screw holes at the rear of the device. Refer to the product installation instructions on the TMC for the location on the 2200T TPS chassis.
